

Pursuant to Article 65, paragraph 7, of the Law on Higher Education ("Official Gazette of the RS", No. 88/2017, 27/2018 - other law, 73/2018 and 67/2019), the Law on Copyright and Related Rights ("Official Gazette of RS" No. 104/2009, 99/2011, 119/2012, 29/2016 - US decision and 66/2019), Law on Protection of Topographies of Semiconductor Products ("Official Gazette of RS", No. 55 / 2013), Law on Protection of Industrial Design ("Official Gazette of RS", No. 104/2009, 45/2015 and 44/2018 - other law), Law on Protection of Business Secrets ("Official Gazette of RS", No. . 72/2011), Article 141 and Article 142 of the Statute of the School of Computing in Belgrade, Teaching-Scientific Council, at the session held on November 22, 2019 passed

Rulebook of Intellectual Property Protection at the School of Computing in Belgrade

Article 1

This Rulebook regulates the procedures of identification, legal protection and further use of intellectual property at the School of Computing in Belgrade (hereinafter: the School).

Article 2

The intellectual good from Article 1 of this Rulebook is any creation of the human spirit that is suitable or could be suitable to be protected by a certain intellectual property right, and which arose as a result of research, scientific, professional and any other activity at the School.

Article 3

All intellectual goods created as a result of research, scientific, professional and any other activity at the School in which the funds of the School are used (equipment, services, human potential, ideas, money, time, etc.), including especially those intellectual goods created in in the teaching process, either at work or in connection with work at the School, **are the exclusive property of the School.**

Article 4

The School can partially or completely alienate the ownership of the intellectual property, which is regulated by signing of a special agreement on the transfer of ownership with the interested party.

Article 5

The School, as the owner of the intellectual property, may license the use of the intellectual property, which is regulated by signing a special licensing agreement with the interested party.

Article 6

This Rulebook applies to:

- 1) persons who are employed at the School during their employment, as well as after the termination of their employment if the intellectual property in accordance with this Rulebook was created at the time of their employment;
- 2) students who participate in teaching, work on research, development and other projects of the School;
- 3) other persons engaged in research and development at the School;
- 4) persons who are hired by the Faculty on the contractual basis.

Article 7

Persons referred to in Article 6 of this Rulebook are obliged to get acquainted with the content of this Rulebook, which they confirm during the signing of the employment contract, supplementary employment contract, engagement contract or study contract.

Article 8

All persons who participate in the creation of an intellectual good, as well as other persons who, by the nature of things or business, may learn information related to an intellectual good, are obliged to keep all information related to the intellectual good as a business secret.

Article 9

The implementation of this Rulebook is to be secured by law and other legal acts from the preamble.

Article 10

This Rulebook shall enter into force on the day of its adoption.
